- I will inform the coach of any physical disability or ailment that may affect the safety of my child or the safety of others.
- 4. I will learn the rules of the game and the policies of the department.
- 5. I, and my guest, will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support of all players, coaches, officials and spectators at every game, practice, or other sporting event.
- 6. I, and my guest, will not engage in any kind of un-sportsmanlike conduct with any official, coach, player, or parent such as booing and taunting, refusing to shake hands, or using profane language or gestures.
- 7. I will not encourage any behaviors or practices that would endanger the health and well-being of the athletes.
- 8. I will teach my child to play by the rules and to resolve conflicts without resorting to hostility or violence.
- 9. I will demand that my child treat other players, coaches, officials, and spectators with respect, regardless of race, creed, color, sex, or ability.
